

Parish Environmental Policy

We affirm these elements of our faith:

- Through Christ, God has created an awesome and majestic cosmos to bring Him praise and glory. We are but one part of His created order.
- Jesus has redeemed the whole earth through His death and resurrection.
- We have a special responsibility to care for the Earth so that human life and all God's creatures may be sustained in harmony.

Aim:

As a local church, we aim to take the practical steps necessary to realise the Fifth Mark of Mission, which is “to strive to safeguard the integrity of creation and to sustain the life of the earth”.

Objective:

We will take environmental concerns into account in all aspects of our church life, including our worship, teaching, mission, pastoral, youth and children's work, training, administration, and charitable giving.

1. Worship, Teaching & Mission, Youth & Children's Work

We will include the importance of care for creation in our worship, teaching and mission, and our work with children and young people.

2. Parish Environmental Champion

We will appoint an Environmental Champion to lead our programme, and encourage him or her to bring relevant environmental issues and concerns forward to the PCC on a regular basis.

3. Eco Church

We will participate in the Eco Church programme.

4. Energy Audit

We will undertake an environmental and energy audit of the church premises and property, identify the most significant issues and impacts which should be addressed and make and implement plans and programmes to tackle them, recognising that some additional costs may be incurred to minimise environmental impacts.

5. Tackling our Energy Use & Carbon Footprint

We will seek to reduce our energy use and our greenhouse gas emissions of the electricity and gas used in church premises by:

- Switching to “green” energy suppliers when our current arrangement ends e.g. Parish Buying (renewably generated electricity and biogas)
- Using thermostats for temperature control
- Fitting LED light bulbs
- Turning off lights, appliances and computers when not in use

- Limiting the use of floodlighting
- Improving insulation wherever practicable
- Investigating renewable heating alternatives

In addition we will try to offset our carbon footprint for those things we cannot reduce.

In the event of the need to undertake a building/refurbishment project, our church would insist that it adhere to BREEAM (or similar) standard to ensure best practice in sustainable building design, construction and operation.

6. Transport

We will encourage our staff and congregation wherever possible to use forms of transport to work, meetings etc. which have minimum or reduced environmental impact – e.g. walk, cycle, public transport, car sharing, electric/ hydrogen vehicles.

7. Food

We encourage people to:

- Use Fairtrade, ethically sourced and animal friendly products when it is affordable for them
- use locally sourced, in season and organic products when it is affordable for them and better for the environment than the alternatives
- Any meals provided by the church will include a vegetarian and/or vegan option.
- The church will take steps to reduce food waste (eg: through composting all waste, minimising leftovers at church meals, partnering with a local food waste scheme).
- The church tries to purchase food with the minimum amount of packaging and to recycle this packaging where possible.

8. Recycling and Unnecessary waste

We will seek ways to reduce material consumption and the impact of our activities on the environment by wherever possible:

- Using email rather than sending hard copies
- Using recycled paper
- Reusing/ repairing items
- Using low environmental impact cleaning materials
- Using recycled toilet paper

9. Water use

We will avoid using water unnecessarily, install water meters where appropriate, check for leakages, fit water minimising systems to taps and cisterns wherever practicable.

10. Churchyard

We will assess our land and property for wildlife and manage them to conserve biodiversity.

11. Sustainable lifestyle

We will encourage individual members of our congregations to take actions in their personal lives to complement and supplement these actions of the church community.

12. Community outreach

We will work with others in our local community to identify environmental issues which should be addressed in our area and help develop actions to tackle them.

13. Charitable Giving

We will consider directing some of our charitable giving to charities which are working to care for the environment or to support those who are adversely affected by climate change.
